## Board Seat Criteria Update

- At the December 4, 2023, OPSC Board meeting, the Board requested additional information related to the Healthcare Consumer seat criteria in ORS 442.830 (2)(d).
  - ORS 442.830 (2)(d): “Representative of healthcare consumers, who may not provide direct healthcare services”
- OPSC received clarification from the Department of Justice related to the two parts of the seat criteria:
  - Should adequately represent the interests of patients in the healthcare system – including anyone who has used, currently uses, or will use healthcare services.

- Cannot directly provide healthcare services to patients – including preventing, alleviating, curing, or healing human illness, physical disability, or injury.
- OPSC will apply the seat criteria clarification to the current candidates for this position before passing along applicants to the Governor’s Office for consideration.
